

## BoatTorch, LLC - Boat Rental Terms and Conditions

**1. Rental Agreement** By renting a boat from BoatTorch, LLC, you agree to abide by all terms and conditions outlined in this document. Failure to comply may result in termination of the rental without a refund.

### 2. Cancellation Policy

- Rentals may be canceled up to **14 days prior** to the rental date for a full refund.
- Cancellations made less than 14 days before the rental date will result in forfeiture of the deposit unless a replacement renter is found.
- Weather-related cancellations are at the discretion of BoatTorch, LLC. The boat will not be rented in cases of thunderstorms, strong winds, or heavy rain. If severe weather prevents rental, renters will receive either a full refund or an option to reschedule.
- If weather conditions only affect part of the rental period, a pro-rated refund will be issued based on the time lost.

### 3. Rental Deposit and Payment

- A **deposit** is required to reserve any boat.
- The remaining balance is due upon pick-up, payable by credit card or cash.
- The renter is responsible for any additional charges incurred during the rental, such as fuel costs or damages.

### 4. Pick-up and Return Policy

- The rental period is stated in the booking confirmation. The return time is strictly **enforced**, unless an extended rental has been pre-approved.
- Late returns may result in additional fees.
- The boat must be picked up and returned at the designated location: **6132 Crystal Beach Rd. NW, Rapid City, MI 49676**, unless previous arrangements have been made.

### 5. Fuel Usage

- The boat is provided with a **full tank of gas**.
- Renters will be charged for the fuel used at the current fuel dock rate.
- The renter is **not** required to refill the fuel tank before returning the boat.

### 6. Equipment and Safety

- The boat comes equipped with **life jackets, throw cushions, anchors, dock lines, fenders, fire extinguishers, and a first aid kit**.
- Renters are responsible for ensuring that all safety equipment remains on board and in good condition.

- The boat has a **maximum capacity** stated on the load information placard. Exceeding this limit is strictly prohibited.

## 7. Renter Responsibilities

- The renter must be **at least 21 years old** with a valid driver's license.
- The renter is responsible for operating the boat safely and complying with all **local, state, and federal boating laws**.
- Alcohol consumption by the operator is strictly prohibited.
- Any damage caused to the boat during the rental period is the renter's financial responsibility.

## 8. Liability Waiver

- The renter assumes full responsibility for any **injuries, accidents, or damages** that occur during the rental period.
- BoatTorch, LLC is not liable for any loss, damage, or personal injury sustained by renters or their guests.
- Renters must sign a rental contract and liability waiver before taking possession of the boat.

## 9. Parking and Pick-Up Information

- Parking is available at a designated lot across from the pick-up location. Renters must use the marked **BoatTorch Parking** area.
- The renter is responsible for ensuring all guests park legally and do not obstruct private driveways or roadways.

**10. Agreement to Terms** By completing a boat rental with BoatTorch, LLC, the renter agrees to all the terms and conditions outlined in this document. BoatTorch, LLC reserves the right to refuse service or terminate a rental agreement at any time if these terms are violated.
